Updated PC Disclosure Guide

Today, Freddie Mac is releasing a new Guide to PC, Giant and REMIC OID Disclosure Information. The Guide will become effective July 1, 2004. The Guide details the addition of a new Daily Breakout File and 51 new data fields. As a result, the record length of the Monthly Breakout File will expand from 75 to 300 characters and the Monthly Quartile file will increase from 300 to 310 characters. AOLS will now be transmitted on a monthly basis for ARMs using an existing data field (see Monthly Quartile File).
