Now Available! – Our Daily Prepayment Rate Dashboard has been enhanced with a new dropdown option to view either cumulative daily prepayment rates or stand-alone daily prepayment rates. With this update, the dashboard has been renamed to “Cohort-Level Prepayments.”

This report will be updated every Wednesday at 4:30 pm and will show the full voluntary payoff activity up to the end of the previous business week, allowing users to monitor the latest prepayment trends prior to the release of monthly factors. To view the report, log in to the Clarity Dashboard and select MBS Data Intelligence, then click on MBS Reports > Cohort-Level Prepayments.

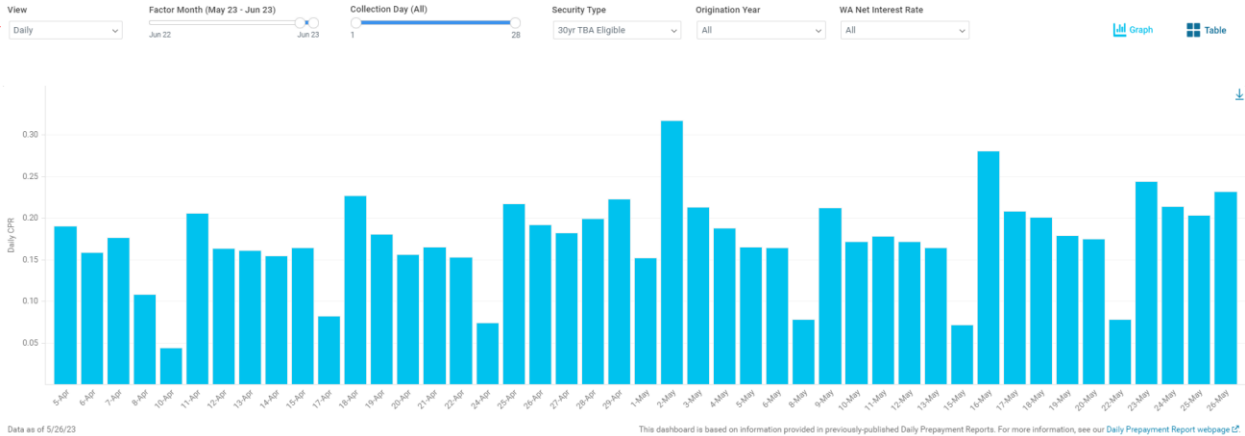
