Freddie Mac Announces the Introduction of Early Disclosure on Guarantor Swap Securities

Beginning in December 2022, Freddie Mac will offer sellers the option for an extended settlement cycle and early disclosure for fixed-rate and ARM guarantor swap securities.

Currently Freddie Mac offers a 3-, 4-, or 5-day settlement cycle for guarantor swap contracts. With this enhancement, Sellers will be able to input a settlement cycle of up to 15 business days, with disclosure of the security available on the first day of the settlement cycle.
