GLOBAL DEBT FACILITY 5.25% Fixed Rate Debt Securities Due October 19, 2015 Redeemable on October 19, 2007 only

This Pricing Supplement relates to the Debt Securities of the Federal Home Loan Mortgage Corporation ("Freddie Mac") described below and should be read in conjunction with the Offering Circular dated June 29, 2005 and all documents incorporated by reference in the Offering Circular including Freddie Mac's Information Statement dated June 14, 2005 and any supplements to such Information Statement. Capitalized terms used in this Pricing Supplement and not otherwise defined in this Pricing Supplement have the meanings given to them in the Offering Circular.

The Debt Securities have the same terms (other than Issue Date and Issue Price) as, and form a single series with, the 5.25% Fixed Rate Debt Securities Due October 19, 2015 that Freddie Mac issued in the principal amount of \$2,200,000,000 on October 19, 2005, \$150,000,000 on February 1, 2006 and \$100,000,000 on February 8, 2006. The aggregate principal amount of the 5.25% Fixed Rate Debt Securities Due October 19, 2015, including the Debt Securities issued pursuant to this Pricing Supplement, will be \$2,550,000,000. See "Description of the Debt Securities - General - Reopened Issues" and "-Maturity, Redemption and Optional Repayment" in the Offering Circular. Interest on the Debt Securities offered pursuant to this Pricing Supplement will accrue from and including October 19, 2005.

The Debt Securities are not suitable investments for all investors. In particular, no investor should purchase the Debt Securities unless the investor understands and is able to bear the redemption, yield, market and liquidity risks associated with the Debt Securities. The Debt Securities are obligations of Freddie Mac only.
