The Medium-Term Notes have the same terms (other than Issue Date and Issue Price) as, and form a single series with, the 5.875% Fixed Rate Medium-Term Notes Due March 6, 2037 that Freddie Mac issued in the principal amount of US\$100,000,000 on March 6, 2007. The aggregate principal amount of the 5.875% Fixed Rate Medium-Term Notes Due March 6, 2037, including the Notes issued pursuant to this Pricing Supplement, will be US\$250,000,000. See "Description of the Debt Securities – Term Debt Securities – Reopened Issues" and "Maturity, Redemption and Optional Repayment" in the Offering Circular. Interest on the Medium-Term Notes offered pursuant to this Pricing Supplement will accrue from, and including, March 6, 2007.

CERTAIN UNITED STATES FEDERAL TAX CONSEQUENCES

For United States federal income tax purposes, the Medium-Term Notes will be part of the same issue as the 5.875% Fixed Rate Medium-Term Notes due March 6, 2037, issued by Freddie Mac on March 6, 2007 (the "Original Notes") and will have the same issue date, the same issue price and the same adjusted issue price as the Original Notes.
