See "Additional Information" in the Offering Circular. Capitalized terms used in this Pricing Supplement have the meanings we gave them in the Offering Circular, unless we specify otherwise.

The Medium-Term Notes have the same terms (other than Issue Date and Issue Price) as, and form a single series with, the 6.00% Fixed Rate Medium-Term Notes Due June 7, 2027 that Freddie Mac issued in the principal amount of US\$100,000,000 on June 7, 2007 and the principal amount US\$50,000,000 on September 5, 2007. The aggregate principal amount of the 6.00% Fixed Rate Medium-Term Notes Due June 7, 2027, including the Medium-Term Notes issued pursuant to this Pricing Supplement, will be US\$250,000,000. See "Description of the Debt Securities - Term Debt Securities - Reopened Issues" and "Maturity, Redemption and Optional Repayment" in the Offering Circular. Interest on the Medium-Term Notes offered pursuant to this Pricing Supplement will accrue from, and including, June 7, 2007.
