The Medium-Term Notes have the same terms (other than Issue Date and Issue Price) as, and form a single series with, the 5.375% Fixed Rate Medium-Term Notes Due December 12, 2017 that Freddie Mac issued in the principal amount of US\$75,000,000 on December 12, 2007. The aggregate principal amount of the 5.375% Fixed Rate Medium-Term Notes Due December 12, 2017, including the Medium-Term Notes issued pursuant to this Pricing Supplement, will be US\$100,000,000. See "Description of the Debt Securities – Term Debt Securities – Reopened Issues" and "– Maturity, Redemption and Optional Repayment" in the Offering Circular. Interest on the Medium-Term Notes offered pursuant to this Pricing Supplement will accrue from, and including, December 12, 2007.
