This Pricing Supplement relates to the Reference Notes<sup>®</sup> Securities (the "Notes") of the Federal Home Loan Mortgage Corporation ("Freddie Mac") described below and should be read in conjunction with the Offering Circular dated July 28, 2006 and all documents incorporated by reference in the Offering Circular, including Freddie Mac's Information Statement dated June 28, 2006 and any supplements to such Information Statement. Capitalized terms used in this Pricing Supplement and not otherwise defined in this Pricing Supplement have the meanings given to them in the Offering Circular.

The Notes are not suitable investments for all investors. In particular, no investor should purchase the Notes unless the investor understands and is able to bear the yield, market and liquidity risks associated with the Notes. The Notes are obligations of Freddie Mac only.
