This Pricing Supplement relates to the Reference Notes<sup>®</sup> Securities (the “Notes”) of the Federal Home Loan Mortgage Corporation (“Freddie Mac”) described below and should be read in conjunction with the Offering Circular dated July 22, 2008 and Incorporated Documents including Freddie Mac’s Registration Statement on Form 10 filed with the Securities and Exchange Commission and declared effective on July 18, 2008. Capitalized terms used in this Pricing Supplement and not otherwise defined in this Pricing Supplement have the meanings given to them in the Offering Circular.

The Notes are not suitable investments for all investors.
