## Freddie Mac Announces New Multifamily PC Prefix

Beginning February 19<sup>th</sup>, 2024, Freddie Mac will start issuing additional 55-Day Multifamily PCs under the prefix of W9 with a range of pool numbers from WV7000 to WV7999. This new prefix is available for 55-day Floating-Rate (ARM) taxable Multifamily PCs with REMIC tax election.

As a result, the pool number range assigned to WV prefix will be adjusted to WV0001-WV6999.
