

This Purchase Contract Confirmation confirms the terms of the commitment of the Seller named below to sell to the Federal Home Loan Mortgage Corporation (“Freddie Mac” or “FHLMC”) conventional Home Mortgages or undivided interest in conventional Home Mortgages in total principal amount to be purchased by Freddie Mac as stated herein, on the terms stated below, in accordance with the Purchase Documents as defined in the *Single-Family Seller/Servicer Guide*, all of which are fully incorporated into such commitment by reference.

This also confirms that all Mortgages sold under the commitment confirmed by this Purchase Contract Confirmation will be serviced in accordance with the terms of the unitary, indivisible master servicing contract comprised of the *Single-Family Seller/Servicer Guide*, applicable bulletins, the applicable MIDANET Users’ Guide (or the MIDAPHONE Users’ Guide), and any other applicable purchase documents, all of which are fully incorporated herein by reference.

The terms of the Purchase Documents in effect on the Date of the Master Commitment shall apply to all purchase contracts under mandatory delivery master commitments. Unless otherwise agreed by Freddie Mac and the Seller, the terms of the Purchase Documents in effect on the Date of Seller’s Offer shall apply to all other purchase contracts, including mandatory delivery purchase contracts under optional delivery master commitments.
