Individuals requesting this role MUST also be authorized by the Warehouse Lender on Form 990SF, Warehouse Provider Certificate of Incumbency, to provide Freddie Mac with Wire Transfer Instructions on behalf of the Warehouse Lender (see Guide Section 6305.12 for more information).
