**Important:** Each Warehouse Provider exists under the laws of the State in which it was organized except for National Banks, Federal Savings and Loan Associations, Federal Savings Banks and Federal Credit Unions, which exist under the laws of the United States.

Information entered in certain fields in Form 990SF will automatically populate applicable fields elsewhere in the form and in the Resolution. For example, when the Seller enters the Warehouse Provider's legal name in the first paragraph of Form 990SF, this information will automatically populate the applicable Warehouse Provider fields elsewhere in the form and in the Resolution.
